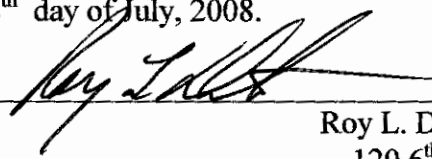

In support of this Motion, the plaintiff relies upon the memorandum incorporated and annexed herewith.

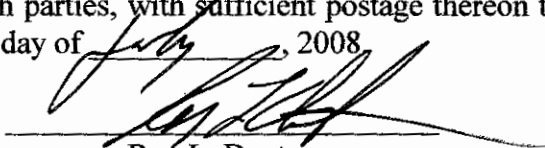
